



Cooperation agreement

Completed between

A: Universal Edition AG, Karlsplatz 6, 1010 Wien, Österreich (hereafter "A")

and

B: Conservatorio Palermo, Via Squarcialupo, 45, 90133 Palermo PA, Italy (hereafter "B")

Article 1 - Purpose of the agreement

The purpose of this cooperation is to support composers of B and make A and B known to a larger audience.

This shall be realized by both parties through mutual promotional activities as defined below. The partners agree on the activities listed in Article 2 and Article 3. The cooperation is exclusively free of charge.

Article 2 - Deliverables of A

- Students and teachers of the conservatory receive a voucher for free submission to Universal Edition
- Students have the option to use a student subscription to scodo (9€/month, 5 works, no music theatre) or a reduced subscription (20€/month, unlimited works) of the publishing tool scodo
- Teachers have the option to use a reduced subscription (20€/month, unlimited works) of the publishing tool scodo
- A creates a landingpage presenting the cooperation as well as the composers who are part of this cooperation
- Post about cooperation in newsletters of A
- Posts about cooperation on social media of A
- Post about cooperation in news area on UE website
- A invites students to a video call once per year to talk about the publishing industry in general and our model in detail

Article 3 - Deliverables of B

- 1 Mailing about the cooperation to members of the conservatory and students (with voucher code for free submission) per year
- Mentioning of the cooperation at events / in front of audience
- Logo placement on-/offline
- URL placement on-/offline
- 1 Article in online and/or offline medium per year
- 4 Posts on social media per year



Article 4 - Confidentiality

"A" and "B" are obligated to treat business secrets of the other parties acquired in connection with the execution of this agreement as confidential and not to disclose them to third parties even after termination of this agreement.

The partners undertake not to make any written or oral statements against the other company or to cause or encourage others to make written or oral statements that defame, disparage or in any way criticize the personal or business reputation of the other company.

Article 5 - Commencement, duration and termination of the agreement

This agreement shall enter into force upon signature by all contracting parties and shall be valid for 1 year from the date of signature.

This agreement may be terminated prematurely for good cause with immediate effect. Termination for good cause must be notified to the other contracting party immediately and in writing, stating the reason.

An important reason is, among other things, if one of the parties does not fulfill the duties and the implementation of the aforementioned provisions within 30 days after a written request.

If one of the contracting parties grossly and persistently fails to fulfill its duties or dissolves the agreement in question without good cause, it shall be liable to pay damages to the other contracting party.

Article 6 - Other

The court with subject-matter jurisdiction in Vienna is agreed as the place of jurisdiction for all disputes arising from or in connection with this contract.

The contract is subject to Austrian law.

All amendments and supplements to this contract must be made in writing to be effective.

Should one of the provisions of this contract be or become invalid, the validity of the remaining provisions shall not be affected thereby. The parties shall replace the invalid provision by a valid provision that best achieves the economically intended result.
